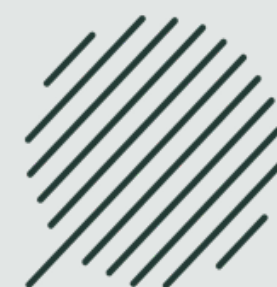

Here's how it works...

Deliberative research brings people together and gives them the **time, space and information to discuss complex topics** in a credible way.



Participants hear from a **variety of sources** – including **expert speakers** and fellow panellists – and follow a logical path through learning and discussion.

We bring together a **representative group of citizens** from all across Scotland, capturing the rich and diverse views of those living here.



We employ a **longitudinal approach**, so participants attend all of the sessions and go through the same participation journey.

This helps participants to foster connections, and reflect on points raised throughout the process.

- Via an online panel
- Aim for 35+ participants

A series of Deliberative Sessions

- Typically over several months
- Includes a range of activities, plus impartial evidence from expert speakers

National Transport Strategy (NTS) People's Panel Pilot

2021



- The National Transport Strategy (NTS) Peoples' Panel brought together 19 members of the Scottish public and supported the delivery of the second NTS.
- 4 online sessions were conducted to focus on each of the priorities and objectives between October 2021 and January 2022.
- The findings were used to inform the development of second annual NTS Delivery Plan for 2022–23.

Deliberative Research on Health Inequalities in Scotland

2022



- This was part of a high-profile project with multiple strands. We conducted the public engagement strand of the Health Foundation's independent review of health inequalities in Scotland.
- We coordinated and engaged a People's Panel of 25 members of the Scottish public with a range of characteristics.
- 4 online sessions were held over four months – participants discussed the issue of health inequalities and reflected on the evidence presented.

OAS People's Panel

2023



- The OAS People's Panel included 30 members of the Scottish public with a range of characteristics.
- 3 online sessions were held to explore public opinion on issues relating to obesity and the food environment.
- Each session covered a different theme; these were Food Deals and Special Offers (Promotions), The Out of Home Sector, and Industry Influence.

Commercial Determinants of Health and Public Attitudes – A Deliberative Approach

2023

- The NCD Alliance Scotland Panel comprised over 30 members of the Scottish public.
- 5 deliberative workshops (x2 online and x3 in person) were held.
- We explored public attitudes and behaviours related to NCDs (non-communicable diseases), including the commercial determinants (price, promotions and availability) which drive the consumption of alcohol, tobacco and high-fat, salt and sugar (HFSS) products.

Public Attitudes to Child Poverty: A Deliberative Research Approach

2024



- The Save the Children Scotland Panel comprised over 35 members of the Scottish public.
- 5 deliberative workshops (x2 online and x3 in person) were held.
- The sessions sought to gain greater understanding of perceptions around causes and solutions to child poverty. The project aimed to address evidence gaps and empower key stakeholders to influence, design and implement more popular and impactful policies.

NHS Reform and Broader Health and Social Care Systems Development: Deliberative Research

2025

- The ALLIANCE Panel included 40 members of the Scottish public.
- 5 deliberative workshops (x2 online and x3 in person) were held.
- The sessions focused on panellists' experiences of current health and social care systems, and views on person-centred care, finance and funding, innovation and change, and policy and communications.

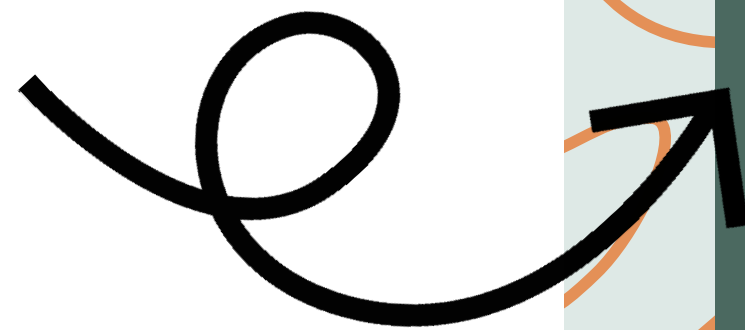
